Completed

Employment and Social Reform Programme (ESRP). The Ministry for Labour, Employment, Veteran and Social Issues and the Social Inclusion and Poverty Reduction Unit called on all interested organizations to submit comments to the final draft programme by 04/09/2015.

The European Union Enlargement Strategy 2013-2014 initiated a new instrument whereby for countries in the process of EU accession priorities will be determined and monitored in the fields of employment and social policy - the Employment and Social Policy Reform Programme (ESRP). ESRP is envisioned as a strategic process, to monitor the process of European integration as the main mechanism for a dialog on priorities in the fields of social policy and employment and structured according to the Europe 2020 strategy model, already applied by member states. ESRP is focused on a limited

number of key priorities in the field of employment and social policy. The entire drafting process is open, and partners were consulted multiple times and invited to take active part in drafting this document by way of various consultation mechanisms.

- Summary of Study "Effectiveness of Systemic Mechanisms for Preventing Violence against Women and Family Violence" The Summary of the study "Effectiveness of Systemic Mechanisms for Preventing Violence against Women and Family Violence" was published by the Social Inclusion and Poverty Reduction Unit of the Government of the Republic of Serbia and the Autonomous Women's Centre from Belgrade. The publication on the effectiveness of systemic mechanisms for preventing violence against women consists of three sections: the first presents an overview of existing strategic and legal solutions and their application, as well as key findings of relevant research in this area during the last ten years; the second presents research findings on the effectiveness and harmonization of system mechanisms for preventing violence against women, viewed from the perspective of professionals from all competent protection services, and the third, based on all the collected data and a consultative process with representatives of state bodies, draws conclusion and recommendations.

In addition to latest data on absolute and relative poverty in the Republic of Serbia, this section of the website also provides data on the extent of inequality and material deprivation in Serbia, the required definitions, as well as a number of useful links.

UN WOMEN in collaboration with the Coordination Body for Gender Equality, Social Inclusion and Poverty Reduction Unit of the Government of Serbia and Republic Secretariat for Public Policies initiated the process of Evaluation of the National Strategy for Improving the Position of Women and Promoting Gender Equality (2009-2015) and the National Plan of Action for the Implementation of the National Strategy for Improving and Promoting Gender Equality 2010-2015. The objective of the evaluation is to carry out an assessment of the progress made under the National Strategy for Improving the Position of Women and promoting Gender Equality, through the indicator based assessment and participatory evaluation that will include key stakeholders, including civil society organizations and to outline key priorities for the new policy cycle. Having in mind that the New Strategy will be drafted during autumn, the findings from the Evaluation will be available in Mid-September and will contribute to the final drafting of the new Strategy for Gender Equality. The final Evaluation Report is expected in Mid-October.
