# Social Inclusion – A Major Development Opportunity for Serbia

At this moment, social inclusion represents a major development opportunity and potential of the Republic of Serbia. This is the issue of involving a segment of population into social trends – those who are currently outside of the systems of education, employment, healthcare, housing and human rights.

In the course of the ongoing European integration process, we have managed to ban widespread discrimination, ensure the right to employment irrespective of personal characteristics, ensure the right to education and healthcare, design a dignified system of social welfare... From the viewpoint of legislation, we have become a more just society.

And still, a segment of our population is still excluded due to an incomplete implementation of regulations, wherefore Serbia, so to say, has fewer inhabitants than the census data may indicate: a significant number of children is leaving school, although education is mandatory, a number of people fail to find jobs because they need support of the society, a number of children fail to receive regular maintenance which they are entitled to, many women are exposed to family violence, which is strictly prohibited by law, some people fail to keep up with technological progress and thus constitute a new group of excluded population, and some people fail to exercise their right to social welfare, even though they are entitled to it.

Wealthy countries are wealthy not only because its individuals are wealthy, but because most population therein take active part in social trends, contributing to the creation and utilization of social wealth and higher social cohesion. People are, therefore, the major potential of Serbia, which may help turn unemployment into employment and dependence into income, and may help youth become the most creative and development potential of a society which thrives for itself and stimulates all others.

Every contemporary society is liable to create preconditions for individuals to use them and meet their full potentials. The new measures and policies which have been and will continue to develop – they depend on strong institutions able to design and put into practice the new and demanding measures. Strong institutions may guarantee the implementation of adopted laws, or that they are amended in order to be able to implement them.

Social inclusion contributes to building a sustainable welfare state. Every excluded person in our society implies less safety and equality in society. Every included and satisfied individual implies personal potentials used to a maximum and a maximum contribution to society's development. Therefore, the main issue before our society should not be – how much social inclusion costs, but what we can do to include the people who have withdrawn from society and who are lost to it.

#### SOCIAL INCLUSION BLOG Movies for the Blind

Is it possible to experience a movie by means of hearing only? The Homer Association of Blind Persons launched a project in 2005 to adapt and synchronize movies for visually impaired persons, aiming to bring movie arts closer to blind and visually impaired persons. I was involved in the project almost as of its start, which proved to be very difficult. We met with misunderstanding more often than with understanding. However, today, seven years into the project, the Homer Association has organized five festivals of movies for the blind, the number of adapted movies has reached fifty, the association's facilities have grown almost into a permanent movie theatre for the blind and, as of recently, movies are screened at the second channel of the national television.

What does an adapted movie look like? It lasts as long as a regular movie, and everything is prepared in advance through audio editing.

The original sound of the movie is audible throughout the movie. At the beginning of each scene, a narrator's voice is heard, which follows the eye of the camera. If a movie tends to be slow and has long shots, as is the case with Tarkovski, sentences are long, descriptive and merge with the spirit of the movie; if shots are short and scenes change quickly, as is the case with Tarantino, the narrator will speak in short sentences allowing the audience to enjoy the movie through voices of actors and sound images of the movie.

# Creating a Framework Favorable to the Development of Social Economy and Entrepreneurship

The Social Inclusion and Poverty Reduction Unit, in cooperation with the OECD LEED programme and the Centre for Liberal-Democratic Studies (CLDS), is conducting a policy impact assessment relating to the development of social economy in Serbia, in particular to the development of social entrepreneurship and the establishment of social enterprises.

The analysis should contribute to the advancement of public policies, in particular in relation to a favorable legal framework and institutional support, access to finances and market, and management of entrepreneurs' skills management.

Social entrepreneurship may contribute to a wider social and economic transformation and employment of hard-to-employ categories of the population. Experiences of some EU member states indicate that social entrepreneurship may be complementary to the market and state interventions. It is estimated that some 10% of all companies in the EU comprise social enterprises and/or 6% of total employment is generated in the social entrepreneurship sector.

There is a small number of enterprises in the Republic of Serbia which may fall within the category of social enterprises. Of all the social enterprises in Serbia, <sup>3</sup>/<sub>4</sub> of the total number are cooperatives, citizen associations, whereas the share of other forms is very small.

The goal of the initiative is a systematic analysis of overall conditions for the establishment and development of social enterprises in relation to the international practices, standards and experiences, a comparison and assessment of strategic measures implemented on the local level, as well as potential measures stimulating the development of social entrepreneurship in Serbia. The initiative will result in a Framework for the Development of Social Entrepreneurship in Serbia – an action plan supporting the implementation the recommendations by setting out a roadmap. This will directly help implement the recommendations of the Government of Serbia set out in the First National Report on Social Inclusion and Poverty Reduction. #### Guide through European Think Tank Organisations Presented

In mid-May 2012, the Social Inclusion and Poverty Reduction Unit of the Government of the Republic of Serbia and the TACSO Project Office in Serbia presented the Guide through European Think Tank Organisations.

The intended purpose of the Guide is to share best practices from the area of creating policies in the EU, and thus provide the state administration, civil society and the academic and business communities in Serbia with a more detailed insight and new ideas for possible directions of activity within the context of European integration, and also within the framework of enhancing the development of national policies in important policy areas.

#### Empowerment and Activation of Young People in Disadvantaged Situations

The social experimentation project addressing the disadvantaged youth entering adult life (Adult Life Entry Network – ALEN) was initiated under the EU PROGRESS in late 2011, programmed to end in April 2013.

The project was been initiated by the Social Inclusion and Poverty Reduction Unit in cooperation with the Croatian Ministry of Health and Social Care and the Hungarian and Austrian Anti-Poverty Networks. In Serbia, the project is implemented by the Ministry of Labour and Social Policy, the Social Inclusion and Poverty Reduction Unit, the Institute of Psychology within the Faculty of Philosophy, the Belgrade University, the NGO Sunce from Kragujevac and the Association for Alternative Family Care Familia from Belgrade.

The overall goal of the project is to contribute to developing innovative social policies related to the social inclusion and adult life entry of young persons in challenging socio-economic situations, by developing and piloting socially innovative approaches and through mutual learning.

The activities in Serbia will cover 10 beneficiaries – youngsters without parental care, living in foster families or homes for parentless children. The project's total budget is EUR 321,000.

### A Project Launched to Promote Higher Education Opportunities for Youth

The project titled Equal Access for All – Strengthening the Social Dimension for a Stronger European Higher Education Area aims to increase chances for young people to enter and remain in higher education, especially Roma, persons with disabilities, rural population, young people with lower educational attainment and other marginalised groups. The long-term goal of the project is to enable labour market access for members of the target groups, which is essential for poverty reduction and social inclusion efforts.

The project also aims to ensure that the most talented persons, who have the capacity but lack opportunities, are given a chance to study, as well as to establish a network of support services for the students at the national level, so as to motivate children as early as during their secondary education and provide support to the students during their higher education studies. The duration of the project is three years.

# **Unemployment Rate in Serbia 25.5%**

The unemployment rate in Serbia totaled 25.5% in April 2012, which is 3.3% higher compared to April 2011 and is the highest since 1998 when the statistics was launched, said the Republic Statistical Office on June 29. Unemployment grew by more than 11% since the breakout of crisis in 2008, with 600,000 people losing their jobs. The employment rate, which represents a percentage of employed persons in the total population aged 15 or higher, also dropped, including undeclared work.

The data are collected through the Labor Force Survey at a sample of 8,000 households. A total of 21,402 persons were interviewed, and data on labor activity were collected for 19,017 persons. The unemployment rate among men and women reached 25% and 26.1% respectively. The employment rate in April totaled 34.3%, which is 1.9% less than in April 2011.

In Belgrade the unemployment rate totals 22.7%, 27.% in Vojvodina, 24.9% in Šumadija and West Serbia region, 26.9% in South and East Serbia region. The informal employment rate totaled 17% in April. Contact: Republic Statistical Office, tel: 011 2412 922

**Open Parliament for Enhanced Parliamentary Work** 

The results of a study conducted within the Open Parliament project showed that in four out of eight parliamentary cycles, more than one half of the cities and municipalities did not have their representatives, while 13 municipalities have never been represented in the parliament.

The website www.otvoreniparlament.rs will be publishing recommendations for enhancing parliamentary work and promoting the communication between the citizens and their representatives, including various analyses and research. The platform contains an archive with more than 67 thousand speeches by MPs from all 98 parliamentary sessions during the past four years.

The project is implemented by the Centre for Research, Transparency and Accountability (CRTA), National Coalition for Decentralisation, Lawyers' Committee for Human Rights (YUCOM), Development Initiative Group (SeConS) and the Zaječar Initiative.

#### Drafting of the National Strategy against Discrimination

#### Number of Complaints Lodged with the Commissioner for Information of Public Importance Increases

The number of complaints lodged with the Commissioner for Information of Public Importance and Personal Data Protection, regarding the inability to exercise the right to free access to information, has markedly increased this year, as well.

The Commissioner has given an estimate that, with the current rate of new submissions, there could be about 6,000 cases by the end of 2012, or 30% more than in 2011, which, in turn, had approximately 40% more complaints than in 2010.

The number of justified complaints is still much larger than of unjustified ones, which points to the necessity to improve the transparency and accountability of the public administration bodies' work.

#### **Municipalities Awarded for Transparent Work**

The European Movement has presented awards for the most transparent local administrations in 2012. The City of Vranje has been awarded for the most transparent public administration by the assessment committee, whereas the Niš Municipality of Pantelej has received the award for the best practice for partnership between a municipal administration and civil society, through an online public vote.

The purpose of the award competition was to implement the 12 principles comprised in the Council of Europe's Charter of Good Governance, with special emphasis on Principle No. 4 – Openness and Transparency, as well as a public campaign for ratification of the Charter for Innovation and Good Governance, for overall benefit of the citizens and the state. # 2013 – European Year of Citizens

The better the men and women of Europe understand their rights as EU citizens, the more informed decisions they can take in their personal lives, and the more vibrant democratic life in Europe can be at all levels.

This is the vision for the European Year of Citizens 2013, which will provide an opportunity for people to learn about the rights and opportunities open to them thanks to EU citizenship, in particular their right to live and work anywhere in the EU, to stimulate debate about the obstacles that prevent people from fully exercising these rights and generate specific proposals for addressing them and to encourage people to participate more proactively in civic fora on EU policies and issues.

This year's activities of citizens and civil society organisations will primarily be organised at the grass-roots level. The target groups are the EU citizens, policy makers at

all levels of government and civil society organisations. The budget envisaged for these activities will amount to

# More than 1.9 Million People in EU Lost Jobs in One Year

During the last 12 months, 1.9 million people lost their jobs in the EU, with the unemployment rate reaching 10.3% in April 2012, Eurostat reported.

This is the record high unemployment rate in the eurozone since the introduction of the euro in 1999, with the total count of job-seekers at the 17.4 million mark.

Estimates say that there were 24.7 million unemployed persons in the EU in April this year, 17.4 million of whom were in the eurozone.

Unemployment is the highest in the countries that are most severely affected by the crisis – Spain (24.3%) and Greece (21.7% according to data from February 2012). Source: eurostat.eu

#### **EU Stimulates Youth Employment**

The European Commission has launched an initiative titled Your First EURES Job, as part of the European proposal stimulating employment in the EU countries.

The European Parliament has adopted the Resolution on Youth Opportunities Initiative, calling for more EU efforts to tackle youth poverty.

It puts forward proposals for devising a "European Investment Plan" to create new jobs by reallocating EU structural funds to projects targeting young people and introducing a "European Youth Guarantee" to ensure that they are not without jobs for more than four months. Source: http://europa.eu

# Poland: EU's Fastest Growing Economy in 2012

Owing to the EU structural funds, which helped public investments grow substantially and thus attract private investments, Poland will be the country with the fastest growing economy in the EU in 2012.

The European Commission's economic forecast contains marked differences compared to its report from November 2011, when the fastest GDP growth in the EU was predicted for Lithuania (3.4%), Estonia (3.2%), Latvia and Poland (2.5% in both countries). Nevertheless, the prospects for the Baltic states have deteriorated, leading the GDP growth forecast to decrease by 1 percentage point for Lithuania, 1.6 pp for Estonia and 0.3 pp for Latvia, whereas the Polish forecast has improved, with the expected growth of 2.7%.

# EU Allocates 8 Billion EUR for Innovations in 2013

The European Commission has announced calls for proposals within the Seventh Framework Programme for Research and Development (FP7), allocating 8.1 billion EUR. The support targets projects and ideas contributing to the competitiveness of Europe, improving the health of people, environmental protection and solutions to new challenges such as waste management. Serbia has been eligible to take part in the program since 2007.

The funds to be granted in 2013 are available for organizations and companies in EU member states and partner states. The funds account for a large segment of the EU budget planned for innovation and research in 2013, totaling EUR 10.8 billion.

Major funds, some EUR 4.8 billion, is earmarked for the naval sector and marine environment, as well as technologies facilitating sustainable development of urban environment. A total of 147 million is allocated for fight against medicine-immune bacteria, some

The European Commission has announced EUR 100 million for innovative solutions in water source management, and some EUR 1.5 billion for information and communication technology projects.

#### EU Opened 51 Calls in a Day!

On July 10, 51 calls for proposals were open through FP7, totaling EUR 3.5 billion. Western Balkans countries may apply for a number of calls open for the non-for-profit and profit sectors.

Special attention will be paid to small and medium-sized enterprizes with a package worth EUR 1.2 billion, and some EUR 2.7 billion should help Europe become a main global researcher destination.

The support targets some 15,000 participants through 1,300 projects.

#### EU Assistance Better Adapted to Regional Needs from 2014

As of 2014, the pre-accession IPA funds of the EU, which are also available to Serbia, should become more adapted to the needs of each individual country. The EU is preparing a new multiannual financial framework, which will also include pre-accession funds for the period 2014–2020.

The plan also envisages that the rules for utilisation of IPA II from 2014 and 2020 should become more flexible and facilitate more efficient use while preparing for EU accession.

Having been awarded the status of an EU candidate, Serbia has become eligible to utilise IPA funds for regional development, agriculture and human resources. However, to be able to do so, it needs to develop the "decentralised implementation system". The Serbian authorities are planning to complete this work by mid-2013 and have it approved by Brussels. Serbia has already applied for the funds intended for agriculture, while the use of funds for employment and regional development will have to stand by until 2014. So far, Serbia has received EUR 200 million annually and this amount should increase by 30%.

# Better Respect for Human Rights

The European Commission has opened a competition for projects aiming to advance respect for human rights and fundamental freedoms in states and situations where these are most jeopardized, and where human rights defenders and civil society organizations face high pressure.

A specific objective is to provide immediate support and protection for human rights defenders and build their capacities, as well as to provide support and funds for civil society activities on the local level, aiming to advance human rights and fundamental freedoms, where they are most vulnerable.

The competition is open for civil society organizations, including non-government organizations and independent political foundations, public institutes, national, regional and international parliamentary bodies, as well as international and regional inter-government organizations.

The budget totals EUR 20 million, and grants total between EUR 300,000 and 1.5 million.

The application deadline is July 20, 2012.

# Social Housing Building in Vranje

A new building for social housing in supportive environment with twenty apartments has been opened in Vranje. Sixteen internally displaced and refugee families from the collective centres and four socially vulnerable families received the keys of the new apartments.

The value of construction work and equipment amounted to EUR370,000, which was financed by the EU within the programme of Support to Refugees and Internally Displaced Persons in Serbia (IPA 2009 funds), with financial support from Habitat for Humanity, Swiss Agency for Development and Cooperation (SDC), the City of Vranje and the Housing Center, in cooperation with the Commissariat for Refugees.

### National Conference on **Employment and Inclusion of PWD**

More than 80 representatives of civil society organisations (CSO), the Government, ministries, local authorities, experts and specialised institutions working with persons with disabilities (PWD) participated in the national conference Through Employment towards Inclusion of People with Disabilities in Serbia".

BCIF also presented the manual Through Employment towards Inclusion of PWD in Serbia, containing an overview of the legal framework for employment of PWD, as well as examples of good practice in this area by CSOs.

Visually impaired persons find it easier to follow a movie if the text of a character is read by another person, meaning that a movie with 50 characters will have just as many speakers reading their roles, and a narrator.

What does the movie screening look like?

The blind come to the association, where chairs are set out just as in a regular theatre. They behave as ordinary audience, though they tend to be a little louder due to their excitement, but due attention is paid once the movie starts.

As of that moment, the narrator and synchronized speakers' voices make every person in the audience their personal director. Each person experiences and imagines the movie in their own way. Once the movie is finished, the audience comments and retells the events from the movie.

Movies are selected against a number of criteria, in particular the complexity of the drama and the plot and characters. Hollywood blockbusters abounding with effects are not easy to adapt.

Adapted movies include film classics such as Citizen Kane, Casablanca and Rashomon, including cult movies such as Pulp Fiction, Taxi Driver and American Beauty.

A large number of persons is responsible for the adaptation of a movie.

#### Roma Integration A Benefit to Society

An analysis of the EU member states' national strategies by the European Commission has revealed that national strategies for improvement of Roma status in the European Union give priority to education, employment and anti-discrimination measures, yet they sometimes fail to address important issues, such as the access to decent housing and healthcare. The Commission stated that "Member States need to extend health and basic social security coverage, as well as to improve living conditions especially in segregated settlements".

Investing in Roma is not only a political act, it also makes economic sense. Research by the World Bank suggests that full Roma integration could be worth around half a billion euros a year to the economies of some countries by improving productivity, cutting welfare bills and boosting tax receipts. # Scholarships for Roma Students

The Budapest-based Roma Education Fund announced the opening of the new application cycle for scholarships for eligible Roma students at secondary or university levels.

The scholarships were intended for Roma pupils who wished to pursue secondary education in medicine, pharmacy, dentistry or other health-related programme, secondary school students of private or public medical vocational schools, as well as the higher education students of medicine studying at colleges or universities according to the Bologna process.

Secondary school and college students will be awarded scholarships in the amount of EUR 1,290, whereas university students will receive EUR 3,335.

Last year there were 133 beneficiaries, of which 13 were young Roma persons from Novi Sad – eight university students and five secondary school students.

# STATE ALLOCATIONS FOR CHILDREN AND FAMILIES **Children Are Not Responsible** for Their Poverty!

A panel discussion was held on state allocations for children and families in Belgrade, mid-June 2012, organized by the Network of Organizations for Children of Serbia (MODS) and the Society for the Development of Children and Youth - Open Club from Niš, with the support of the Social Inclusion and Poverty Reduction Unit of the Government of the Republic of Serbia and UNICEF.

Secondary school students, members of the children's council of MODS, called on the adults for action, noting that "Children did not choose, they had no choice, and when they are born in poverty, they live in poverty."

The joint conclusion from the discussion is that changes should be considered in the application of the programme of child allowance that would lead to improved targeting and recognition of various needs of the approximately 400,000 children receiving child allowance. The complex bureaucratic procedures were also pointed out, along with the fact that three out of five children with rights to child allowance do not make use of this right. Apart from increasing budget allocations and changes in procedures, quality services should be provided for childcare, better education, as well as the protection of child rights.

#### **Initiative: Improving Social Protection of** Women and Children - Victims of Violence

The Autonomous Women's Centre, the Human Rights Council of Vranje and "... From the Circle - Vojvodina" requested changes to the local policy in Vranje and Novi Sad, while the Women's Centre in Užice requested changes in Užice, aiming for the more efficient protection of women and children, victims of family violence.

Changes were proposed in Vranje to documents regulating the accommodation of women and children, victims of violence at the Shelter for Victims of Family Violence, as well as to rights in social protection. More detailed regulation of criteria for the accommodation of women and children, victims of violence at the Shelter was requested, of terminating provisions prescribing that women victims of violence pay for the accommodation, as well as providing a safe space for women and children, victims of violence.

Initiatives in Novi Sad and Užice relate to amending town decisions on social protection, aiming to introduce a new right to monetary assistance and expanding the circle of users of the right to social housing in protected conditions for women victims of family violence.

The activities are part of the project "Towards Social Cohesion Impact of Social Inclusion Policy for Multiply Marginalized Groups of Women Victims of Violence", financed by the EU.

3G Routers were set up in public transportation vehicles in Belgrade, providing free access to wireless internet to passengers.

In order to make internet service in vehicles available to a greater number of public transport users, the lines with wi-fi devices changes and are not fixed. This option is available in Belgrade, with the installation of devices in vehicles in other larger cities currently ongoing.

The idea, implemented by the Masel Group, involves companies using this system of advertising in addition to the existing ones. Having watched a commercial on their mobile device, passengers can use the free internet during their journey to find information or stay in contact with friends.
