Poverty and discrimination represent key obstacles for the social inclusion of the Roma. Accordingly, the overall goal of the Strategy is improving the socialeconomic status of the Roma national minority in the Republic of Serbia, with a full achievement of minority rights, elimination of discrimination and the achievement of greater social inclusion of Roma in all The Strategy also tends to respond to the following key issues for achieving the envisaged strategic goals:

1. How to implement the goals of the Strategy? Establishing a clear mechanism for planning, implementation, monitoring and evaluation of the goals of the Strategy is required; 2. Who is responsible? Capacities and the level of responsibility of stakeholders at all levels and in all segments of society need to be raised; 3. Through what funds? The priority is the coordinated allocation of funds from local, national and

- the Roma community and the implementation of the Strategy. We should not forget that Roma experts are experts for all citizens. A Roma person professionally executing their duties contributes to their community
- and society as a whole. In the field of employment, emphasis is placed on the inclusion of capable members of the Roma national minority in the labour market, the improvement of their employability and employment. However, as with
- many other citizens, the issue of creating jobs remains open due to the overall unfavourable state of the field of economic development. Groups vulnerable from multiple aspects have been recognized in the field of social protection, such as

children and youth engaged in living and working in the street, mothers, victims of human trafficking, returnees in the readmission process, etc. Still, some members of the Roma community remain invisible, such as persons with disabilities, LGBTI and elderly persons of Roma nationality. Additionally, the Strategy envisages the improvement of the system for collecting data in the field of social protection, in order to

obtain clear and regular data on the realization of the rights of Roma in this field. The goal of such an approach should be to reach those most vulnerable, currently not encompassed by the support system. During the current period, with the participation of all relevant institutions/organizations and individuals, an Action Plan will be developed and adopted for the implementation of the Strategy for 2016 and 2017. The measures envisaged by the Strategy will largely be related to the local level, thereby enabling it to reach its end users in a faster and more direct manner.

Secondary School Students Enabled to Certify Entrepreneurial Knowledge through Entrepreneurial Skills Pass Supported by the Social Inclusion and Poverty Reduction Unit, the organization Junior Achievements in Serbia enabled secondary school students to this year certify their entrepreneurial knowledge and skills. This is a novelty, both in Europe, as well as our country, intended for those students participating in the Student Company programme. It is the Entrepreneurial Skills Pass, representing a new international method for gaining qualifications and obtaining certificates, and serves as confirmation that the students (aged 15 to 19 years) adopted the knowledge, skills and competence required for employment or self-The first step in gaining this certificate was made by 234 students from 40 secondary schools from across Serbia. Over 600 teachers from 200 secondary schools were introduced to this method of certification of the attendants to the Student Company programme early this year, therefore the number of students is expected to increase several times during the next school year. Workshops Held for Exchange of Experiences in Professional Practice The Social Inclusion and Poverty Reduction Unit, in cooperation with Belgrade Open School (BOS) and with the support of the Swiss Agency for Development and Cooperation, organized an exchange of experiences and good practices in organizing professional practice in Serbia on 29 and 30 March 2016 The workshop was the venue for presenting experiences and problems regarding the selection of practitioners, working with them, as well as the planning and duration of professional practice by representatives of organizations organizing professional practice, such as the National Employment Service, the Centre for Career Development of the Faculty of Philosophy (Belgrade) and the University Centre for Career Development (Belgrade), along with representatives of organizations providing practice — Union of Employers of Serbia, Economics Institute (Belgrade), Centre of New Technologies (Ruma) and BOS. Experiences in organizing professional practice as an integrated model were also presented by the representatives of the project "Youth Employment Promotion — GIZ YEP". Visualisation of MESTD Open Data – Award Competition for School Programming Teams (Deadline: 12/05/2016) The Ministry of Education, Science and Technological Development (MESTD), in cooperation with the Social Inclusion and Poverty Reduction Unit of the Government of the Republic of Serbia, is issuing an award competition titled "Visualisation of MESTD Open Data". The competition is open for secondary school programming teams from across the Republic of Serbia, led by a school mentor (teacher, professional associate or school principal). The goal of the competition is to increase student interest in programming, as well as to stimulate secondary schools to develop their engagement with interested students, while at the same time promoting the open data concept. The task for school teams is to create a visualization of a dataset (or combination of datasets) from the MESTD information system available from the MESTD open data portal, by 12 May 2016. 48h LeanLab Successfully Completed The entrepreneurial hackathon 48h LeanLab, an event designed and implemented by Impact Hub Belgrade in cooperation with the Social Inclusion and Poverty Reduction Unit of the Government of the Republic of Serbia, was completed successfully. Combining a methodology similar to a hackathon with mentorship, Design-Thinking methodology, Core-Competence skills and advocacy, the event took place during the 48 hours between 1 and 3 April.
