The Social Inclusion and Poverty Reduction Unit of the Government of the Republic of Serbia has initiated the second phase of the "Local Initiatives for Increasing Social Inclusion and Poverty Reduction" programme. The call covers two regions in Serbia: Southern and Eastern Serbia, and Šumadija and Western Serbia, i.e. 53 local self-governments. The goal of this programme is to contribute to the social inclusion of vulnerable social groups through the development

of innovative approaches to social inclusion at the local level. This programme will support partnerships of local selfgovernments and civil society organizations to formulate and implement innovative approaches to social inclusion across five areas: education, employment, healthcare and protection of health, social welfare and housing. Local initiatives that will be supported should endeavour to ensure a better quality of life for all citizens in the local community, particularly women, youth, Roma, migrants and persons with disabilities, through improving existing and establishing new innovative approaches, and/or innovative measures, services, and programmes. As part

of the "Local Initiatives for Increasing Social Inclusion and Poverty Reduction" programme, local selfgovernments will be provided with support for developing innovative measures, services, and/or

represent practices, processes, services, methodologies or combinations of all of the above, aimed at responding to a recognized unmet need in society, or a social issue in the local community. With this in mind, the proposed ideas should respond to real social issues in the local community and contribute to the development of cooperation and partnerships between various sectors to eliminate inequalities in the local community, inform final beneficiaries on their rights, and empower them for participation in public policy The first phase of the "Local Initiatives for Increasing Social Inclusion and Poverty Reduction" programme was implemented during the 2015-2016 period. The goal of the programme was to provide support for

partnerships of civil society organizations and local self-governments with the aim of creating, implementing, monitoring and evaluating strategic and legal frameworks in areas of significance for social inclusion and poverty reduction and establishing cooperation with other relevant stakeholders from the public, private and civil sector, at the local and regional level. The programme supported 11 local initiatives across five thematic areas - education, employment, social welfare, social housing and rural development. More on the supported initiatives, most important activities implemented, and their effects can be found at the website of the Social Inclusion and Poverty Reduction Unit. The implementation of the second phase of the programme will be coordinated by the Social Inclusion and Poverty Reduction Unit of the Government of the Republic of Serbia, with the financial support of the Swiss Agency for Development and Cooperation (SDC). - Example number one of public transport. In addition to workers of the city transport company with absolutely zero sensitivity towards the needs and issues of persons with disabilities, we are also faced with the problem of a very low number of low-floor buses.

Belgrade, the city I love, is often a "mine field" for me.

The next issue creating difficulties for movement are high curbs, even those where certain interventions have been made, but inadequately, or to say it more precisely, poorly. I use a walker with four wheels and brakes, and every time I see a sidewalk I get the chills, because I know I will have to make a serious effort to get my walker up onto it. This requires strength of arms. My advice: start lifting weights, if you are using

Now, imagine people who do not even have a house, who do not even have this basic living space that we take for granted. Five thousand of them live like that in Belgrade. Five thousand people! Those are the ones sleeping in doorways and pressed against the wall as we step around them in the passage under

Terazije. Even more of them huddling in abandoned buildings, ruined factories... They may have a roof

I used to wonder – man, how did these five thousand end up in the street? Well, now, how did they end up in the street – it is much easier for a person to end up in the street than we think. Imagine, for example, going to school, having a family, having a job, a rented apartment. You lose your job, fail to make ends

and four walls, but that is all they have – no electricity, no water, no safety, no warmth.

our human nature crumbles in this way of life, our dignity is eroded, our hope departs – because this is not a humane life, intended for human beings. This is why a group of people in the ADRA Srbija organization has started DrumoDom, an adapted bus visiting locations where these people reside and offering them the opportunity to take a shower, to use a proper toilet, to get a haircut, to talk to those that can talk and are not in any hurry while talking or listening to someone. Perhaps a small miracle may occur: that strength, hope and vision are awakened in these

Now imagine yourself using a wheelchair and trying to get to an important place in time, but there have not been any low-floor buses for a while, and you are, of course, late. Or an even worse example, if you

One thing I find concerning is that a large number of schools and faculties are inaccessible, begging the question of how we are supposed to get our education. Example: the Faculty of Mechanical Engineering, with all its innumerable stairs, looks from my perspective as if I'm about to conquer Mount Everest. So, if we are wondering why the majority of persons with disabilities are insufficiently educated, one reason lies in the inaccessibility of educational institutions. (...) Social inclusion primarily involves physical presence, and that cannot happen without an accessible environment.

This evening I will tell you about houses and homes. (...) Having one's own living space is

meet, you fall into a crisis, lose your family, lose your place - voilà, you are on the street! Or you are a child, a young person, 18 years of age, spending your entire life without parents, the state taking care of you. You come of age, you leave the institutions... it is so easy for things not to come out right. Or, for example, you are a person with psycho-social issues, without support (not a rare thing), and without the resources to make your way... Or you are simply a person who has made too many dumb moves in your life... Or even more frequently, all these elements, mixed up in a hellish tragedy where you can't even tell what is whose fault.

Anyway, you find yourself in the street, and once that happens, after a while, you accept it as your choice, because we, people, even in chaotic situations, tend to proclaim them to be our choice. This makes it easier to survive, it is a completely human thing to do.
